## PARK AMENITY DONATION INSTRUCTIONS:

- 1) Complete the following donation application and submit to the City of Tucker Parks & Recreations Department via parks@tuckerga.gov
- 2) You may designate a specific park for your donation. Once you submit your application, the City of Tucker Parks & Recreations Department will contact you to determine the most appropriate location within the designated park.
- 3) The costs shown for benches and trees are the *estimated* range for the total cost of items and includes a commemorative plaque, shipping, and installation. Final cost will be determined once the location and availability of the item are determined. The City of Tucker Parks & Recreation Department will inform you of the exact cost prior to you your donation payment.
- 4) Wording for the commemorative plaque must be approved by the City of Tucker Parks & Recreations department. Plaque wording may be limited per line.
- 5) Donation payments should be made to Friends of Tucker Parks, Inc. in the form of a check. Payments may also be made via PayPal at <a href="mailto:donate@tuckerparks.org">donate@tuckerparks.org</a> for an upcharge of 2.2% to cover processing fees. A tax receipt will be issued for all donations from Friends of Tucker Parks, Inc., a 501(c)(3) non-profit.
- 6) Once your donation payment is received, the item will be ordered. The City of Tucker Parks & Recreation Department will inform the donor of the scheduled installation time once the item is received and installation scheduled. For donated trees, the best time of year to assure tree health will be considered when scheduling the installation.
- 7) The donated items become the property of the City of Tucker. The City of Tucker will maintain the item. If the item or plaque is vandalized, damaged, or stolen, the City of Tucker Parks & Recreation Department will make any repairs based upon their judgment. If item and/or plaque are damaged beyond repair the parks department may choose to remove and not replace the item unless an additional donation is made. The City of Tucker Parks & Recreation department will strive to notify the donor if the item must be removed.
